## 2021 Fresno Open

**Location:** The Fresno Rifle and Pistol Club, Fresno, CA, Range #8.

**Date:** May 29, 30, & 31, 2021.

**Time:** Saturday, May 29 60 shot 880 yd. Match  
Sunday, May 30 60 shot Team 880 yd. Match  
Monday, May 31 45 shot “Heartbreaker” Palma Match  
Monday, May 31 5 shot “Wind God” Match  
Squadding will begin at 0730 with the first shot at 0800. Shooters arriving after squadding has finished will not be accepted.

**Match Fees:** Fresno Open 5/29 \$40.00 per adult, \$10.00 per junior.  
Team Match 5/30 \$10.00 per firing adult, \$5.00 per junior  
Cowpie Palma Match 5/31 \$25.00 per adult, \$10.00 per junior.  
Wind God Match 5/31 \$0.00, limited entry.

Package fee for all individual matches (1-4 and 6) \$50.00 per adult, \$20.00 per junior.  
**Entries:** All entries must be made by using the enclosed entry form and accompanied by a check payable to Fresno High Power Club. No portion of the match fee will be returned to a competitor who fails to make a cancellation. Entries for match 5, the team match, must be made by the team captain at the range to the statistics officer. A team name must also be submitted at that time.

**Rules:** NRA High Power rules will apply.

**Classification:** NRA Long Range & F-Class classification will be used.

**Divisions:** Sling, F-Open, F-TR

**Rifles:** For Fresno Open, NRA service rifle (rules 3.1), any rifle (rule 3.2, iron sights only), F-Class (rule 3.4),  
For Cowpie Palma, Service Rifle (rule 3.1), U.S. Palma Rifle (rule 3.3.1), or F-Class (rule 3.4)

**Scoring:** Competitors will score for one another. Failure to perform scoring duties will be grounds for disqualification. Score cards will be turned in promptly to the statistical officer after each stage of the match.

**Range Service:** We will be using electronic targets. Competitors are expected to help with target set-up and take-down, as directed.

**Challenges:** If no E-target error message is present, and the target appears to be functioning, the e-target shot value will be final.  
Other circumstances will be resolved at the match director's discretion.

**Course of Fire:**

**Saturday, May 29, 2021.**

**Fresno Open:** Unlimited sighting shots and 20 shots for record in 30 minutes, prone, slow fire, 880 yards.  
2 sighting shots and 20 shots for record in 30 minutes, prone, slow fire. 880 yards.  
2 sighting shots and 20 shots for record in 30 minutes, prone, slow fire, 880 yards.

**Sunday May 30, 2021.**

**Team Match:** Team 880 Yard Match (rule 7.12)  
3 Stages, each consisting of 2 sighting shots and 20 shots for record.  
Team size will be determined based on the number of entrants.  
Teams will be assigned by the match director.  
Other rules may be implemented at the match director's discretion.

**Monday, May 31, 2021.**

**Palma:** Modified Palma Individual Match (Cow Pie Palma).

**Course of Fire:**

Unlimited sighters and 15 shots for record in 22 minutes at 600 yards.  
2 sighters and 15 shots for record in 22 minutes at 800, and 880 yards.  
*The 600 yard MR target will be used at all distances.*

**Wind God Match:** A completely made up format, open to the first and 2<sup>nd</sup> place finishers in each category of the Cowpie Palma, 6 shooters total.

**Course of Fire:** 2 minutes for 2 sighting shots. ***After the sighting period is complete, shooters will not be allowed to look at the e-target monitors.*** Each shooter will have 1 minute to fire 1 shot. After this minute has expired, each shooter will have 1 minute to fire their second shot. This will continue until 5 minutes, and 5 shots have elapsed. High score is the winner. Category will not be considered, there will be a single winner. If there is a point & x-count tie after the first five shots, additional shots will be fired at 1 minute intervals, until the tie is broken. *The 600 yard MR target will be used.*

**Award Schedule:**

**Fresno Open:** Sling Match winner, F-Class Match Winner, F-TR Match Winner; plaque.

**Team Match:** (team match): Awards will be based on aggregate scores in the team match. Individual members of the winning team will receive awards.

**Cowpie Palma:** Plaque for Match Winner, F-Class Match Winner, F-TR Match Winner.

**Wind God:** \$50 and bragging rights.

**General:** The line officer's decisions will be final. Any person deemed unsafe by the line officer will be ejected from the range immediately.

**Liability:** The Fresno Rifle and Pistol Club accepts no responsibility for personal injury, theft or property damage involving competitors or spectators. Competitors are required to sign a liability waiver.

**Accommodations:**

There is space for self-contained campers on the front side of the range. There are no electrical, water or sewer hookups.
